OUTDOOR

Smart Controllers. To be eligible, controllers *must* include all the following features:

- 1) A ‘Seasonal’ or ‘Budget’ adjustment control.
- 2) An ET-, Weather-, or Soil Moisture-based control that matches watering schedules to actual weather patterns.
- 3) Programmable for multiple programs, stations, and start-times.

Rotator Heads or Nozzles. These heads are designed to replace spray heads and deliver precipitation that is matched, with lower flow rates, more even coverage and less runoff.

Drip Irrigation Systems. All main lines, piping, emitters, pressure regulators, filters, flush valves, backflow preventers, and up to 2 battery-operated timers per system. Emitters must be rated at 15 gallons per hour or less.

Soil Amendments. Any commercially-produced compost product. NO MULCHES.

Water System Check. To be performed and completed by any competent adult.

INDOOR

Clothes Washers. Only CEE-approved machines are eligible for rebate. (See list on Web site.)

High Efficiency Toilets. Only units that have dual-flush operations and/or rated to use 1.28 gallons per flush or less are eligible. (See list on Web site.)
